Subject : **Revision of LITE Starter Pack as Qualification Requirement of Revenue Share Upgrade and Receiving of Shared Members**

Dear TONE PLUS and TONE WOW Members

Our memo dated 5th December 2019 (Ref: TONE/20191205/01/EN) referred

Item 2(b) in the memo stated that:

- b. With immediate effect, LITE Member will no longer be eligible as fulfilment of this condition. Only PUSH, PULL and Biz Member will be eligible as fulfilment of qualifications.

After taking into various feedback and considerations, the above-mentioned will be revised as follows:

- b. With immediate effect, LITE Member to only be considered eligible as fulfilment of Qualification for the sponsoring Member's Revenue Share Upgrade and Receiving of Shared Members, if the sponsored LITE Member perform TopUp of minimum RM 30.00 within Three (3) Calendar days from date of registration.

Further to that:

- a. LITE Member that perform TopUp of minimum RM 30.00 within Three (3) Calendar days from date of registration AND has fulfil the mandatory four direct members (PUSH, BIZ or LITE with TopUp of RM 30.00 and above within 3 calendar days) will be entitled to Revenue Share Upgrade and Receiving of Shared Members
- b. PUSH Member can be upgraded to BIZ Member by payment of RM 100.00 at TONE HQ Counters (or via WOWlet available after 15th January 2020).

With the revision of this policy, effective **19th December 2019:**


- i. Lite Members registered before 19th December 2019 will be allowed until **25th December 2019** to perform minimum RM 30.00 TopUp to fulfil the new policy
- ii. Lite Members registered on and after 19th December 2019 will be required to perform minimum RM 30.00 TopUp within Three (3) Calendar Days to fulfil the new policy

The revised policy ONLY APPLY TO MEMBERS THAT HAVE NOT FULFIL the **Qualification Requirement of Revenue Share Upgrade and Receiving of Shared Members.**

We are confident that with the revision of the above, TONE PLUS and TONE WOW PLUS Members will be able to expedite their recruitment, and increased their income.

Ahli-ahli TONE PLUS and TONE WOW PLUS

Memo kami bertarikh 5 Disember 2019 (Ruj: TONE/20191205/01/BM) dirujuk

Perkara 2 (b) didalam memo menyatakan bahawa:

- b. Berkuat kuasa serta-merta, Ahli LITE tidak lagi layak sebagai memenuhi syarat ini. Hanya Ahli PUSH, PULL dan Ahli Biz layak untuk memenuhi syarat kelayakan.

Selepas mengambil maklum balas serta pertimbangan rapi, polisi tersebut akan diubahsuai seperti berikut:

- b. Berkuat kuasa serta-merta, Ahli LITE hanya layak untuk memenuhi syarat kelayakan untuk Kelayakan Peningkatan Perkongsian Pendapatan dan Penerimaan Perkongsian Ahli, jika Ahli LITE yang ditaja melakukan Tambah Nilai RM 30.00 dan keatas dalam tempoh tiga (3) hari dari tarikh pendaftaran .

Tambahan lagi:

- a. Ahli LITE yang melakukan Tambah Nilai RM 30.00 dan keatas didalam tempoh tiga (3) hari dari tarikh pendaftaran DAN telah memenuhi mandatori empat (4) ahli langsung (PUSH, BIZ atau LITE dengan Tambah Nilai RM 30.00 dan keatas dalam masa 3 hari) layak untuk Kelayakan Peningkatan Perkongsian Pendapatan dan Penerimaan Perkongsian Ahli.
- b. Ahli PUSH boleh dinaik taraf kepada Ahli BIZ dengan membayar RM 100.00 di Kaunter TONE HQ (atau melalui WOWlet selepas 15hb Januari 2020).

Dengan Penyemakan semula dasar ini, yang berkuat kuasa **19 Disember 2019:**

- i. Ahli Lite yang berdaftar sebelum 19 Disember 2019 akan dibenarkan sehingga **25 Disember 2019** untuk melakukan tambah nilai RM 30.00 dan keatas untuk memenuhi polisi baru ini.
- ii. Ahli Lite yang didaftarkan pada dan selepas 19 Disember 2019 dikehendaki melakukan tambah nilai RM 30.00 dan keatas dalam tempoh Tiga (3) Hari untuk memenuhi polisi baru ini.

Dasar yang disemak semula ini HANYA TERTAKLUK KEPADA AHLI-AHLI YANG DITAJA DAN BELUM MEMENUHI SYARAT Kelayakan Peningkatan Perkongsian Pendapatan dan Penerimaan Perkongsian Ahli sahaja.

Kami yakin bahawa dengan semakan semula kriteria kelayakan, Ahli TONE PLUS dan TONE WOW PLUS akan dapat mempercepatkan penajaan mereka, dan seterusnya meningkatkan pendapatan mereka.


